Prorated Schedule

Junior membership dues are prorated based on the month of application. Membership renewal occurs annually due July 1 of each year.

Work hours are required of all members in addition to annual dues. The number of hours required is set by the Board of Directors and is currently six (6) hours per year. Members can pay a fee of \$20 per hour or \$120 dollars due at enrollment or renewal, to satisfy the work hour requirement.

Membership in the Junior Olympic Archery Development (JOAD) program is \$100 annually.
